Wi-Fi is available at the Skills Center, so there should be no problem using your card reader.

Light refreshments are available for purchase. An area with tables for shoppers to sit down, relax and enjoy the day will be provided.

Live music will be provided to help create a festive atmosphere throughout the Holiday Market.

**Guidelines:**

**Basics -**

- Vendors must be 18 years of age or older to participate, unless accompanied by an adult.
- We accept handcrafted items, fine art and hand-made gourmet specialty foods, produce. Select items approved by the committee.
- We do not allow representatives – the artist/crafter who created the product must be the one attending the show.

## **Application and Fees -**

- The entry fee must be accompanied by the application form. Your application will not be accepted until you have paid.
- All fees are nonrefundable. Application deadline is January 20, 2018. Spaces are limited. All fees are per stall.
- After January 20 fees per stall are \$45 for market members and \$60 for non-members. Signing up early helps guarantee you a stall, applications received after deadline are placed as to availability or put on a waiting list.
- A confirmation e-mail will be sent with any information after January 22. Cashed checks are to be considered a definite confirmation - check your bank statement!
- If you are placed on the waiting list your application and fee will be held. If space does not become available is the only reason a refund will be granted. Refunds will be issued by February 24.

## **Booth, tables, chairs -**

- Each booth is 8 x 8 with the exception of corner booths which may be a bit larger due to the layout.
- Vendors may rent two booths if needed, but that is not guaranteed.
- There are a limited number of tables available at the facility. If you need a table or two please let us know. When all of the tables have been spoken for you will be notified and will be expected to provide your own tables. Chairs are available for vendors to use.
- All displays should be contained within the assigned space.

## **Facility guidelines -**

- Absolutely NO nails, pins, tacks or tape may be used on walls. If you need to hang up a sign please use poster putty.
- No canopy frames will be allowed. If you have items that need to be hung please don't wait until the last minute to figure it out.
- State law prohibits smoking of tobacco or other substances and the consumption of alcohol on school grounds. This is an absolute. If you choose not to adhere to this policy, you will be removed from the Holiday Market and no refund will be issued

**Time schedule for market day -**

- Doors will open at 6:00 a.m. Saturday morning for vendor set up. All booths must be completely set up by 8:30 a.m. Saturday morning.
- Vendors are expected to stay with your table/booth space intact until 2:00 p.m. and be packed up by no later than 3:30 pm.
- Please be courteous to other vendors while moving in and out. We are all trying to make money. Everyone is moving as fast as they can.
